ABOUT THIS DOCUMENT

This document outlines the necessary procedures to set up your agency management system to receive download information from the Freedom Companies. Since procedures vary with different vendor systems, you will need to refer to your agency management system documentation for the specific information required to complete the setup screens. THIS SETUP MUST BE COMPLETED <u>BEFORE</u> FREEDOM CAN START DOWNLOADING TO YOUR AGENCY.

LINES OF BUSINESS/TRANSACTIONS RECEIVED THROUGH DOWNLOAD

Freedom will be downloading the Personal Auto line of business only. The types of transactions that will be downloaded are:

- New business
- 2. Re-writes
- 3. Renewals
- 4. Endorsements
- 5. Cancellations
- 6. Reinstatements

NOTE: Non-renewals <u>will not</u> be downloaded. Coverage rescissions will be downloaded as cancellations.

POLICY NUMBERS

Freedom's personal auto policy numbers contain 9 alpha-numeric characters, with no spaces (3 character prefix + 6 digits. For example: ABC123456). If your agency management system currently stores Freedom policy numbers in a different format, you must update them in order for the download to find a match.

AGENCY MANAGEMENT SYSTEMS

Freedom currently downloads to the following Agency Management Systems: Hawksoft, InStar, Applied (TAM, Vision, DORIS, Epic), Quomation PowerManage, Ebix ASP, FSC Manager, ITC Insurance Pro, Insure Now *.

(*) NOTE: Indicated systems are in the process of certification, and will be in production shortly.

INFORMATION NEEDED FOR SETUP

In order to set up for download, you will likely need the following Freedom-specific information:

1. NAIC Codes

Freedom will download for the following NAIC Codes:

10783F (Cornerstone National Insurance Company)27502F (Western General Insurance Company)

2. Origination Address

Freedom Origination Address - IBM949FNI

<u>NOTE:</u> Only agents with **AfW** and **AMS360** need to enter this address as part of their company set up.

3. Company unique coverages

At this time Freedom does not have any company unique Coverage codes.

4. 5BPI20 Company Product Codes:

California Producers

CCA = Freedom Camino Program

WCA = Freedom Vanguard Program

Arizona Producers

CAZ = Freedom Falcon Program **WAZ** = Freedom Summit Program

Colorado Producers

CCO = Freedom Condor Program

AFTER COMPLETING THE SETUP SCREENS

- 1. Once the set up process is complete, fill out the form below and either return it to your marketing representative, or fax it to: **866-324-0987**.
- 2. You will be contacted when we are ready to download the test batch for your agency. The Freedom test download will consist of 5-6 recent transactions (one of each type), for real policies from your book of business.
- 3. After you confirm the success of the test download, Freedom will prepare the initial download (if requested by the agency) based on your choice indicated on the form below.
- 4. Starting <u>next day</u> after the initial download has been completed, your regular downloads will begin on a daily basis. All daily transactions (except non-renewals) processed for your agency code(s) will be downloaded to your agency management system, usually within 24 hours.

Note: **NOT recommended** option unless the book of business is reasonably small. Do not perform any initial downloads, just start downloading the daily transactions.
